The Chief Executive and Town Clerk, the Director of Finance, the Director of Housing and Property and the Assistant Chief Officer (Environment) were in attendance.

4. Standing Order 39 – Question – Mr Councillor D.J. Ashford

Mr Councillor D.W. Christian to ask the Chair of the Environmental Services Committee:

In relation to Braddan Lodge, Quarterbridge Road:

- (a) In which year was the first Enforcement Notice served on the owner?
- (b) In each and every year how much has been spent on Legal Services/Court Costs?
- (c) Over the same period how much has been awarded in Costs to the Council?
- (d) In the same period what have been the estimated costs in relation to Staff?

Reply:

- (a) The original complaint was investigated in May 2000 and the records appear to show that the first enforcement notice was issued around October 2005;
- (b) The legal costs for the period 2011 to date are £15,756.65. The costs for each year are, 2011/12 £1,380.50, 2012/13 £0, 2013/14 £0, 2014/15 £6,442.02, 2015 to date £7,934.13. It has not been possible to provide details of the legal costs for the period prior to 2011;
- (c) In 2015/16 the court awarded costs of £13,064 in favour of the Council;
- (d) The cost of officers' time for the Derelict Buildings Service is not separately allocated to individual properties. Due to the length of time that the complaint has taken to resolve and the number of staff involved it is not possible to provide a meaningful estimate of costs.
