The Chief Executive and Town Clerk, the Director of Finance, the Director of Housing and Property and the Assistant Chief Officer (Environment) were in attendance.

1. **Minutes – 2nd March, 2016**

The minutes of the Special Council Meeting held on Wednesday, 2nd March, 2016, were approved and signed.

2. **Minutes – 9th March, 2016**

The minutes of the monthly Council Meeting held on Wednesday, 9th March, 2016, were approved, subject to amendment of a clerical error in Clause 16. Councillor Mrs C.E. Malarkey's name appears twice.

3. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner to ask the Leader of the Council:

Question:

In relation to Notices of Excess Parking Charge issued by the Borough Wardens:

- (a) under what legislation, Act or Order do the Borough Wardens have powers to issue Notices of Excess Parking Charges to drivers for failure to display a current valid Road Fund Licence (tax disc) in Car Parks?
- (b) in each month and in each car park how many such Notices have been issued since the Council took over the management of car parks from the Department of Infrastructure?
- (c) how many such notices have been successfully appealed?
- (d) for what other offences can the Borough Wardens issue Notices of Excess Charge in car parks?
- (e) who receives the income from the Excess Parking Charges for such offences?

Reply:

(a) Part 2 (7) of the Douglas Borough Council Off-Street Parking Places Order 2015 states:

"The driver of any vehicle shall not leave it on any car park unless there is displayed in or on the vehicle in the prescribed manner, a valid vehicle licence issued by the Isle of Man Government under the Licensing and Registration of Vehicles Act 1985, or by some other agency appropriate to the jurisdiction in which the vehicle is registered."

Excess charge notices for failing to display a valid vehicle excise licence have been issued since January 2015 following confirmation that the 2015 Parking Places Order had been registered.

- (b) The numbers of such charges issued by month and by car park since the Council took over management of the Chester Street and Drumgold Street Car Parks are as set out in Table 1 attached.
- (c) Since 1st January 2016 there have been 46 appeals against Excess Charge Notices issued for failing to display a valid excise licence. 33 appeals have been accepted, 11 have been rejected and 2 are currently open.
- (d) The Douglas Borough Council Off-Street Parking Places Order provides for numerous offences for both drivers and non-drivers. Any person convicted for contravening or failing to comply with the provisions of the Order would be liable to a fine not exceeding £500. However, the Order provides that an Excess Parking Charge may be issued as an alternative to prosecution.

The current IT system used by the Borough Wardens contains the following categories of offence for which the Borough Wardens can issue Excess Charge Notices under the Car Parks Order:

- Parking after the expiry of the ticket displayed.
- Parking without a valid ticket displayed.
- Parking other than between the markings of a parking bay.
- Parking on a reserved space without displaying a valid permit.
- Parking other than in a permitted parking bay.
- Parking on a disabled space without displaying a valid permit.
- Parking whilst failing to display a valid vehicle excise licence.
- Avoidance of Payment.

It is proposed to add a category for other offences.

(e) The Council receives the income from Excess Parking charges.

4. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner to ask the Leader of the Council:

Question:

- (a) In each month since the Council took over the management of the car parks from the Department of Infrastructure how many Notices of Excess Charge have been issued for 'Failing to Park within the Lines' of the designated parking bays in each of the car parks managed by the Council?
- (b) Who receives the income from the Excess Charges for such offences?

Reply:

- (a) The details are set out in Table 2 attached.
- (b) The Council receives the income from Excess Charges.
